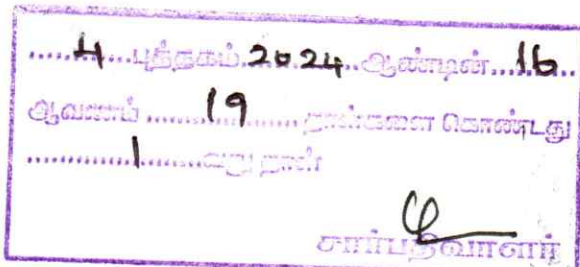

This **DEED OF DECLARATION OF TRUST** is executed at Venkadareddiyur on 19-07-2024 **BETWEEN**

Whereas the **AUTHOR OF THE TRUST** has decided to create and establish a Trust for the welfare of the community at large without discrimination of caste, Creed etc. with objects and constitution as hereinafter set forth.

Whereas it is necessary and desirable to declare and constitute the said Trust and to record the objects and constitution of the said Trust.

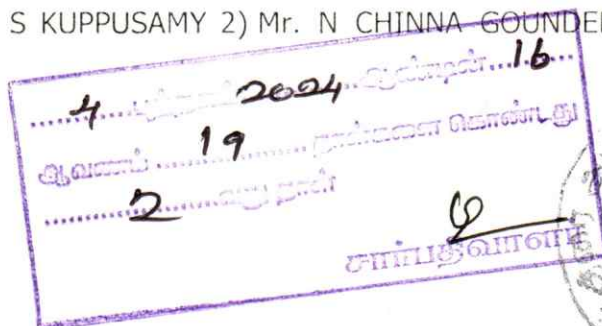

CREATION OF THE TRUST: In pursuance of the intention, the **AUTHOR OF TRUST** has settled the sum of Rs. 5,000/- in the form of cash/property unto and in favour of the Trustees herein to be held by them for and on behalf of the Trust hereby created and known as Shri Mariamman Kovil the receipt of which sum of Rs. 5,000/- which has already been handed over to the Trustees mentioned hereunder, is hereby acknowledged by the Trustees, who hereby accept the appointment as such Trustees of the said Trust, under the terms and conditions, set out hereunder for the fulfillment of the objects of the Trust, more fully and particularly described and set out hereunder.

The History of The Shri Mariamman Kovil Situated at Venkadareddiyur.

Venkadareddiyur Shri Mariamman Temple is the name of the temple and the history is stated below.

As per the oral tradition and going by the rituals conducted by the families (25 presently) that are associated with this temple , the temple dates back close to 1880 and even earlier. The Shri Mariamman is the Kaaval Deivam or Goddess of Protection for all these families and some of them might have migrated or moved out in the past. In this region Shri Mariamman is the Kaaval Deivam(Protecting Deity) of many hamlets big and small and all Hindu families will have a family associated with their own Shri Mariamman Temple named after the place in each Taluk or Village.

This region and surrounding places are known for the worship of Sakthi as a primordial Goddess of Protection and during early 1900 until 1980's many family functions, and first tonsuring of Hair of the child, ear piercing, and Aadi Month celebrations was conducted with lots of dedication and devotion in respective temples including Venkadareddiyur Shri Mariamman Temple.

During the late 80's the temple administration faced severe financial difficulty as the families were wholly dependent on Agricultural income. For the unknown reason they have to curtail some of the annual functions of the temple, however the families connected to the temple made sure the temple was maintained and it was functioning with minimal support.

With the support of the Villagers and the 25 families connected to the temple meeting was held in 2022 post covid to reinstate the glorious past of the Temple, as there were many health and other challenges was imposed on the village and one of the reason that was mentioned was that the Shri Mariamman Temple was not taken care properly and that might be the reason for such hardships.

After consulting Hindu Priests, those who are experts in the field of Temple consecration, and the Hindu Almanac, the 25 families took the decision to renovate the temple as per the Shastras and due process such as Balalayam for the Thirumeni of the Amman was done. We also installed a Murti of Gaja Lakshmi while the renovation work was on and Gopuram work is in progress. By the Grace of Shri Mariamman and Gaja Lakshmi we hope to have the temple consecration / Kumbhabhishekam ceremony soon, which will become a place of Blessings, Peace and Prosperity for this region.
